Membership of ASGMA 2018-19

Thank you for expressing an interest in being a member of ASGMA.

Membership helps towards funding our activities and services, and being a member is a condition of receiving our newsletters and accessing our services and activities.

The cost is £28 per year for individuals and families. A concessionary rate for individuals and families of £14 may be available, subject to meeting certain conditions (see over). New members are entitled to their first month free of charge; as our membership year runs from 1st April one year to 31st March the next, the first year's membership fee depends on when during the year you join.

If you wish to take up membership please return the attached membership form back to us either with the payment attached or confirmation that you have paid online.

A concessionary rate of membership may be available to individuals or families in receipt of two or more of the following benefits:

- Income support or Income Based Jobseeker's Allowance
- Income Related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- Child Tax Credit / Working Tax Credit, with total household income under £16,190
- Guarantee Element of Pension Credit
- Universal Credit

Eligibility in respect of benefits will be re-assessed on each renewal of membership.

Individuals in receipt of Direct Payment or Personal/Individual Budget care packages and their families will not normally qualify for the concessionary rate, regardless of other benefit status.

Members must provide evidence of the benefit(s) and sign to confirm the information.

Procedure:

Applications for the concessionary rate will initially be assessed by the Operations Team Leader. Any applications from individuals or families not in receipt of the specified benefits but who are nevertheless disadvantaged or otherwise subject to hardship will also be assessed by the Operations Team Leader. Any appeal against rejection of a concessionary rate application will be considered by the Operations Manager.
